Repertoire Requirements

- **Each participant shall perform:**
 - **One Sonatina or Sonata movement, and**
 - **One additional contrasting piece, differing in style and historical period**
 - **Original compositions are required/no arrangements, adaptations, simplified or shortened versions are allowed**
 - **Pieces performed must be of the same level of difficulty**
 - **Students need to present the original sheet music to the adjudicator prior to performing**
 - **Performing by memory is encouraged but not expected**
 - **Students not performing by memory need to have two original versions of the music (one for the adjudicator and one for the student). Unmemorized pieces will get a deduction of 5 points per performance.**
 - **Music produced from CD files, procured from public domain sources as Petrucci Music Library (imslp.org) or electronically purchased music is acceptable. Repeats are generally not to be taken in the Sonata or Sonatina movement, except for short repeats (8-12 measure), or for balance of form. At the discretion of the teacher, repeats may be used in the contrasting piece if it serves to enhance the music. Both the D.C. and D.S. should be taken as indicated**
 - **Illegal photocopied music is not allowed**
 - **Measures need to be numbered**
 - **The total performance time may not exceed 10 minutes for intermediate and 15 minutes for advanced level performers**
- **Primer, Level 1, and Level 2 students are not required to perform a contrasting period piece but are required to perform a contrasting piece in style**
- **Student requirements:**
 - Students should arrive 10-15 minutes prior to the recital
 - Students/ families must be present during the entire scheduled recital
 - Students should dress appropriately for the occasion

Teacher Responsibilities

- All participating teachers are expected to assist with event duties as assigned to ensure the successful operation of the recital.
This event is intended to promote musical growth, stylistic awareness, and performance experience through constructive adjudication in a professional and supportive environment.
